## AquaKids® Rental Agreement Contract

AquaKids® shall be available for use by the public on a reservation basis subject to the conditions outlined below. The purpose of these guidelines is to establish standard procedures for administering the policy and to insure fairness in the renting of the facility.

The applicant reserving the facility agrees to read and abide by the following:

1. You agree to indemnify and hold harmless AquaKids®, its agents, and employees from and against any claims for damages to persons or property arising out of any use of the facility and its premises by user. AquaKids® assumes no responsibility for any property placed in or about the facility.
2. All children under the age of 3 and everyone not potty-trained must wear a cloth, non-disposable swim diaper.
3. All children under the age of 4 must have an adult accompany them in the pool.
4. You agree to assume all responsibility for any damages done to the premises as a result of their usage. User shall assume the costs for repair and/or replacement based on AquaKids® assessment of damages.
5. All reservations must be confirmed with this written contract, entitled "AquaKids® Rental Agreement Contract," signed and approved by AquaKids®. The user fee of \$\_\_\_\_\_ for two-hour party must be paid at the time of registration. (See your location for pricing)
6. You agree to leave the premises in as good or better condition than existed prior to their usage. All liquids should be disposed of into the sinks; all tables and chairs should be put away in their original location; all decorations must be removed.
7. The party is welcome to congregate in the lobby fifteen minutes prior to the reserved party time. The lifeguards will meet your group and escort you into the party room where you will be allowed to set up for your party. The format of the party is one hour and fifteen minutes in the pool, followed by forty-five minutes in the party room. In order to keep a timely fashion, please help us clean up the party room and leave at your scheduled time.
8. User shall be permitted to use only the pool room and the party room and not the swim school office, lobby, parking lot, or yard around the building for any party related activity.
9. AquaKids® does not permit alcoholic beverages or the use of tobacco products on its premises or in the area surrounding the facility. Nacho cheese, crepe paper, confetti, and high-powered water guns are prohibited. No tape or tacks may be used on walls or ceiling.
10. You agree to pay an additional **\$5.00** per swimmer for each guest over the count of **20**.
11. Two lifeguards are provided to host you and your guests during your party. If you have 30+ swimmers, a third lifeguard will be required at an additional **\$25**.
12. Rental fees are nonrefundable. In the event that you would like to reschedule, a **\$40.00 rescheduling fee will be charged**.
13. AquaKids® reserves the right to cancel the reservation due to conditions that would deem the facility or pool unsafe for use (e.g. inclement weather, improper chemical balance, etc.). If AquaKids® cancels the reservation, the rental fee will be credited to your account and your party will be re-scheduled for the next available time.
14. For safety reasons, if your location has a small pool, it will be closed for the party.
15. Items provided to you by AquaKids®:
  - Twenty invitations
  - Two lifeguards
  - Three 6-foot long tables with chairs, set up in the party room

YOU MAY CHOOSE TO TIP A LIFEGUARD WHO HAS PROVIDED EXCEPTIONAL SERVICES.
