



AquaKids® Spring 2019 Payment Plan Guidelines and Agreement

As a convenience to AquaKids® customers, we are offering the opportunity to pay for lessons in an installment plan. Online registration is not an option for those who wish to participate in the payment plan as the system will charge the entire session cost. Parents may register their children in person or by phone. The following outlines the specifics of participating in the payment plan.

Read and initial the following statements

_____ A credit card on file for AutoPay in your parent portal is required to participate on the payment plan. (Go to www.aquakids.com, click blue enroll online button, and log into your parent portal to save credit card information). AutoPay credit card information must be on file before attending your first lesson.

_____ The total class cost plus a \$15 processing fee is divided into three installments. The first installment is due at the time of enrollment. AutoPay transactions will be processed for the two remaining installments on the 26th day of March and April.

_____ By signing up to participate on the payment plan, you are stating that you are arranging payment for the entire 2019 Spring 12 week session. Should you decide to withdraw from class, a written 30-day notice is required before you stop coming to class so that AquaKids® may assign an exit date and fill your child's space in that class. If you do not give a 30-day notice, you will be charged for the classes whether or not you attend.

_____ If AquaKids® is unable to obtain authorization; a \$10 fee will be assessed to your account. If you wish to make payment by cash or check, you must do so on or before the 25th day of each of installment months. Credit cards will be processed on the 26th day of each installment month on accounts that have a balance due. AquaKids® does not make "reminder" phone calls regarding monthly payments.
